We will be electing three new Class B (alcoholic) Trustees at the General Service Conference in April 2005: Class B regional Trustees from the East Central and Southeast Regions and Class B Trustee-at-Large/U.S. will be elected to serve four year terms.

We received our Area Group Contribution Statement for the first three months ending March 31,2004. We show 564 groups in our Area, unfortunately we show 30 groups unknown. 20% of groups contributed in 2004, compared to 18% in 2003. Our total contribution was \$10,359.14.

Bill A., our Conference Coordinator for the 54th General Service Conference was admitted into the hospital following the Conference. He was expected to have surgery last week. I haven't received an update on his condition as of last week. Please keep him and his family in your prayers.

1. I attended the Tuesday night A.A. meeting around the corner after the "Delegates Only" Meeting. About thirty to forty Conference members attended. 2. One of the Delegate's adult daughters was in New York with him and one night she had too much to drink, blacked out, and was missing for a number of hours. The next morning he asked for our prayers and as he was the chairman of his committee, he put his daughter in God's hands and presented his committee agenda items to the conference. The next day, Friday, he shared how she was found and was being taken to an AA. meeting by a G.S.O. staff member.

These two events during the week: one in the beginning of the week and one at the end, just reinforced the spiritual nature of A.A. business during the 54th General Service Conference. Once again, I thank Area 32 for allowing me to be of service as your Area 32, Panel 53, Central Michigan Delegate.
