GSO Conference Committee: The committee approved a request from the chairman of the AA Central Mexicana General Service Board that two of their Trustees attend the 2008 GSC as observers and agreed to forward the request to the 2008 Conference Policy/Admissions Committee.

Corrections: The General Service Board Corrections Committee reviewed the final changes requested by the 2007 GSC to the DVD - "AA in Correctional Facilities." The committee approved the DVD for production, sale and distribution should have started in September, 2007, and the price will be \$8 each.

International Convention: Inquiries about the upcoming International Convention, July 1<sup>st</sup> - 4<sup>th</sup>, 2010, in San Antonio, TX., continue to arrive at GSO daily. Preliminary information has been posted on GSO's AA Web site and published in Box 459.

The International Conference of Young People in AA: (ICYPAA), was held in Los Angeles over Labor Day weekend, it was a great success with over 3,700 in attendance.

Public Information: "A Force of Nature", the television Public Service Announcement (PSA), approved by the 57<sup>th</sup> GSC is now being distributed by Banyan Communications. Several local PI Committees have begun projects to distribute the PSA to television stations not reached by this project.

AAWS Publishing Committee: The committee discussed a request that the AA Service Manual and Twelve Concepts for World Service (SBM-31) in Spanish be made available in large print format, similar to the large print English language version. The committee recommended that the item be published in large print format and priced at \$7.80. The Board approved the committee's recommendation.

Just a reminder, in the months of Nov. & Dec. we will be having another Central Michigan Intra Area 32 inventory, the inventory will be chaired by our Alternate Delegate, Mike K.
