Delegate Report, Area 32 Assembly, Bay City October 7, 2018

Good Day Friends and Fellows,

I stand before you on a day of change, of transformation from what was to what will become and I ask you to reflect upon not just what is transforming within our little corner of the world, but how the entire world around us is transforming and breathe in the flow of life itself as the egg to the worm, the worm to the butterfly, who after leaving vestiges to the future passes on to another form.

I ask a prayer of hope and strength to the upcoming representatives of these changes within our fellowship. And as Dr. Bob and Bill Wilson recognized the need to step aside and allow this change, I ask that we also welcome the new.

From Bill Wilson's 1960 Conference Talk:

Well, I'm so glad that the decision for change was taken. This ushered in a whole new era in our affairs and began to put them service-wise upon a sound and permanent basis. And this involved just really replacing Dr. Bob and me with you people, who have come here to stand in our shoes: you have become the linkage between our trusteeship and the movement. We took the risk, and you people showed us that it wasn't a very big one, because the success of this thing has exceeded our wildest imaginations. Therefore, we enter this twenty-fifth year stepping across one more threshold into the future. What does the future hold for us? What may its perils be like? How can we strengthen ourselves against the time of peril? To put it negatively. To put it positively, how can we increase our communication with the sea of drunks around us? I realize that while on behalf of all, I've been saying nice things about us — congratulating us on our successes so far — we ought nevertheless to soberly reflect that this society has made only the smallest scratch on the total problem of alcoholism."

Regarding the Conference Final Report: The report is considerably longer than its predecessors, in part because of all the material related to the Manuscript issue which is included in full as part of the report of the General Service Board; additionally, by Conference action, the committee considerations of each committee, along with the delegate area highlights, are printed in their entirety, requiring additional time for translation, etc., whereas in prior years these aspects of the report were simply summarized; and the unusual confluence of events stemming from additional Conference actions that put 3 totally revised pamphlets, two completely new pamphlets, a bevy of other corrections and updates, and an every-other-year edition of the Service Manual (all of these items in 3 languages) on the publishing plate at the same time.

Since the August Assembly I have traveled around the Area giving Delegate Reports, attending functions, and participating in the 2018 Michigan State Convention Slash East Central Regional Conference. This was, I feel a 100% success and applaud Area 34 for a job well done. The facility and staff were great and we were made to feel welcome. The panels were interesting and speakers outstanding. I had the honor of introducing Past General Service Board Chair and Class A Trustee the Reverend Ward Ewing. He was in inspiration to me and many others at the event.

A couple more workshops and Reports are coming up for me as well as participating in the Michigan Convention of Young People in Alcoholics Anonymous. Rick, Carlyle, and myself will be manning a General Service outreach table and hope to assist in any way possible.
