He will be contacting the Meeting Guide App and streamline this process and get it up and running. Website is working on becoming more mobile friendly. Tracy suggested getting a link where all current flyers are uploaded. Safe Site certification issue is on hold for the time being.

#### OLD BUSINESS:

• Mark M. explained how Area 33 holds all meetings at the same building and the host district changes. He stated that he thought that the Emergency Services Building could possibly be a centrally located place within Area 32 to consistently host Area Assemblies. John B. expressed concerns about districts at the outer edges of our Area hosting so that their GSR's and AA's in general can attend in their area. Lori C. stated that Area 33 is a confined area and 32 is much large. Rotation around our entire Area works because the varied locations. Ted S. suggested that if we do vote to switch to a central location, a set donation amount will be given to the host district according to the 7<sup>th</sup> tradition. Each district determines whether to use the stipend.

### **NEW BUSINESS:**

Pete and Heidi G. resigned their positions as they are moving to a new Area. Jon S. was introduced as the new Chair. John S. reviewed the reservations for hosting 2020 Area meetings. Charlie from Hillman (28 will take June 2020, and 26 will take August due to the elections coming up for 2021). Feb 2, April 5, and December 6<sup>th</sup> are available for 2020. Mark said that it is likely that District 10 will host February 2020. Stephanie offered that District 18 could host December in 2020 (in Howell) but it was suggested that District 18 look for a venue within its parameters as there is ample time to find one.

- Ethan read his request letter to the body regarding a request that GSO publish a YPPA pamphlet for AA. (use letter for reference) Signed by Lori, Don and Ethan. Ted requests that bid letter be accepted and submitted with proofreading and corrections by Secretary prior to mailing. Traci mentions that YPAA meetings are listed on meeting schedules and they want to get rid of a separation between AA and YPAA. Lori stated that YPAA was brought up at the GSO convention but did not make it to the trustee committee for Agenda. She stated that the young people have a lot to offer and we have a lot to learn from the way they do things. It needs to keep resurfacing until it gets attention. Motion carried to send letter.
- Lori C. International Convention the Delegate does not get reimbursed for attendance at the International Convention. She is asking for funds for the registration and room fees etc. for the Delegate and Alternate Delegate to reimburse them for the International Convention in 2020. The trustee from ECR assumes that the delegate and alt delegate will be participating in the convention itself. She is asking for \$230 total to cover registrations. Dennis is a past delegate and says he wishes Jack were there, this event is a convention and not a business meeting. No previous delegate has ever been given money for this convention. Heidi stated that she would rather see the money spent to send a newcomer to the convention. It was voted on and determined that Area 32 will not spend extra funds to pay the registration fees for the delegate and the alternate delegate for the 2020 International Convention.
- John B. stated that attending Forum more than once allows a person to become familiar with how it runs. The more seasoned a person is, the more likely they would be to ask questions and make suggestions. Sometimes when a person attends meetings, they see a need for something to be provided that is not. He started the CPC meeting. There are many ways to address the alcoholic ensnared in the court system. He said he has many sponsees who have completed the 12 steps and go on to service who came into the program "on paper". He put together an agenda item to rewrite the present guideline. The current guideline reads like an ad. They presented evidence and more information. They formed a subcommittee to study it. That committee came back that the desk should rewrite it. A new person was elected, and a new guideline was written but they ignored what was brought to them. John would like this body to discuss it, in an informed manner, and eventually decide. He brought his ideas to forum and this what feedback he got. He has rewritten a draft guideline to assist groups in having an informed group conference. The packet seeks to find a way to be more effective finding people who need our help. Less than 50% of drunk drivers are alcoholics. There is a synopsis of the agenda item. There are 2 CD recordings about how we are sending misinformation.

He would like the group to review 2 documents and then comment about whether a new agenda item or an appeal be made. Pete suggested that the body take the copies back to their groups to come back in October ready to discuss with the body. Kate stated that the synopsis needs to cite the source of the information. John is passing out his e mail for further questions.
