Archives Committee had 3 recommendations and all 3 passed.

- 4.A commemorative 75<sup>th</sup> Anniversary Edition of the first edition ,first publication of Alcoholic Anonymous to be published in April 2014.
- 5. The posting of freely accessible, anonymity protected archival audio clips on GSO's AA Web site be done at the discretion of the Trustee's Committee on Archives and G.S.O Archivest.

Finance.No recommendations.Our contributions are running about the same as last year at 42% to 46%.

Corrections.1recommendation.The committee recommended that the revised pamphlet "A Messagee to the Correction Professional be approved.The change was in the text of the pamphlet.I have a copy of the text that was changed.

Policy/Admissions-4 recommendations-2 Approved. The dates of the 2016 General Service Conference. April 17-23 2016 was approved. The user Guidelines in the Guide for Electronic Devices at the General Service Conference be revised. Approved. To changed the deadline for Agenda Items deadline from Jan. 15<sup>th</sup> to Dec. 15<sup>th</sup>. Approved.

Treatment/Special Needs –Accessibilities No Recommendations.

Grapevine Committee-No Recommendations. The Grapevine is getting high renewals. Not getting new Subscriptions. The Grapevine workbook is on line..

Agenda Committee-2 recommendations.1.The Theme for the 2014 General Service Conference be "Communicating Our Legacies-Vital in a Changing World".Approved.

A)Recovery, Unity and Service-Our Responsibility.

Public Information-1 Recommendation. It was approved that the 63<sup>rd</sup> General Service Conference affirm that the Internet, Social Media, and all forms of public communications are implicit in the last phrase of the short form of Tradition Eleven which reads.. "At the level of press, radio and films."

AA World Services be permitted to utilize digital channels and current (commissionable) support And distribution technologies, such as, but not limited smart phones, tablets, ereaders, applications and commissioned online stores for the sale and distribution of digital AA literature The committee requested that the board ensure all contracts protect our Traditions, with the option to discontinue any contracts at any time.

Report and Charter -5 Recommendations A typo error in :Leadership in AA:Ever a Vital Need contained within the essay on Concept IX on page 37 fifth paragraph third line be corrected to "badly disturbed or uninformed." in the next printing noting this has existed since the first printing of Twelve Concepts for World Service.

The Text describing the duties of the chairperson of the General Service Board be added to Chapter Nine in the AA Service Manual location be determined by the Publishing Dept.

The 2010 Advisory Action regarding Area Highlights be rescinded, so the entire Final Report may be professionally edited and published, while still reflecting the full substance of the General Service Conference.

The Principle of Rotation be added to page S23 of the AA Service Manual after the section entitled "Stimulating Interest in General Service".

International Conventions-1 Recommendation. The 3 cities for the 2025 International Convention are: Montreal, St. Louis and Vancover, also recommended up to 21 non AA speakers to be invited.

Literature Committee-1 recommendation. Draft pamphlet AA-Spiritual not Religious be recommitted To the Trustee Literature Committee and be brought to the 2014 Conference.

Cooperation with the Professional Community-3 Recommendations.In the pamphlet "If you are a Professional "be revised to read.Have the AA groups secretary sign,initial or stamp a slip that has been furnished.The word stamp was added.

In the statement how to reach AA add www.aa.org.

The Trustee's Committee on CPC revise the pamphlet "If you are a Professional..." taking into consideration suggested changes of the CPC Committee and bring back a report to the 2014 Conference Committee.

We had 6 floor actions to consider none of the floor actions were approved.
