#### DELEGATE RÉPORT

# Central Michigan Intra Area Area Assembly

December 6, 2015

Good afternoon:

I wish you all a very Merry Christmas and a Happy New Year!

At the D.C.M. meeting this morning I gave a more comprehensive report to your district committee member as to what has transpired at our General Service Office since our last assembly in October. That report can be shared at your upcoming district meetings.

As the year comes to an end, it seems the pace has slowed down a bit for me. I have given seven delegate reports to the fourteen districts beginning in June and ending in November.

In those reports I have tried to emphasize the importance of districts' visiting the groups within their districts. Often registered groups don't have a G.S.R., or if they do have one, their G.S.R. hasn't been seen at a district meeting or an area assembly. Please arrange for annual group visits to both the registered groups and those many unregistered groups. In the Fellowship we all need each other. The groups, their members, need to be connected to A.A. as a whole. We can all try a bit more in the coming months to do what we can to reach out to those groups whom we need here to share their experience, strength, and hope.

Some of the nuts 'n bolts:

### General service Office - A.A. World Services

A.A.W.S. publishing through September had gross sales 15.07% below the budgeted estimates.

Revenues in general were 9.7% less than budgeted in the first nine months. Contributions were nearly \$100,000 dollars below budget and 25,000 less than the same time last year. The net loss for the period was \$284,000 compared to the budgeted profit of \$63,000. The projected loss for 2015 is \$200,000.

A likely reason for the year-over-year loss can be attributed to the Big Book price increase in October 1, 2014. Groups, individual, Central Offices, areas etc. all sent in large orders for Big Books before the price increase became effective.

## Grapevine/La Viña

A.A. Grapevine sales are YTD ahead of projections; in fact, they are \$322,000 ahead of projections. Through September A.A. Grapevine had a budgeted projected loss of \$21,000 but realized a net income of \$208,000 and interest from the Reserve Fund of \$35,000 more than projected. This was coupled with a significant decline in expenses that accounted for the gain rather than loss.

Circulation of the print magazine averaged 72,495 for the first nine months, and that was 2,307 ahead of budget. That number, however, was 1,759 lower than the same period in 2014. Budgeted gross profit for 2015 is forecasted to be \$45,222 less than in 2014.

The North American A.A. Grapevine subscription challenge ends in two weeks on December 20th. The challenge has been not so much in increasing print subscriptions but in stemming the tide of decreasing subscriptions. If you don't subscribe, consider subscribing. The cost is \$28.97/year for 12 issues. Each issue has 62 pages or more, 20 or more stories--sharing on that month's Step and Tradition. The cost is less than .08¢ a day.

La Viña income is ahead of budget by \$4,201 but still had a shortfall for the period of \$99,673. Circulation was 10,310 or 297 copies less than budgeted. Cost and expenses for the nine months ending September 30 were \$11,118. La Viña is a service piece to the Spanish-speaking community. And as a service piece the magazine is not required to make a profit.

# 2015 International Convention

The 2015 International Convention held in Atlanta, Georgia had *nearly* 57,000 attendees garnering revenues of \$5.9 million dollars. Expenses, however, were \$6.1 million dollars. The costs exceeding revenue are being attributed to higher numbers of attendees requiring more hotels located farther away from downtown, significantly more buses traveling more miles, more security, more equipment for those with special needs.

There is much, much more information to be had. If you have questions, I'll attempt to answer them or provide you with answers from the people I have met who do know.

I thank you all for allowing me to represent Central Michigan Intra Area at the annual General Service Conference, the Statewide General Service Committee, the Conference of Delegates Past and Present, the East Central Regional Conference, our State Convention and many other venues. The journey in A.A. I have found to be limitless. Thank you all for being here, and more importantly for being there for the still sick and suffering. Please take copies of the 2015 General Service Conference Final Report; take one for yourself and for anyone else who would find the information useful.
